DISCOVERING OLD WELSH HOUSES

HOUSE HISTORIES of some FARMS in Dyffryn Ardudwy, Merionethshire.

HENDRE FECHAN, Llanaber / Llanddwywe parish, Merionethshire. NGR SH 596213.

Hendre Fechan is located to the east of the A496 main north / south road between Talybont and Llanaber, north of Barmouth. It is situated on sloping land above the coastal belt of poor pasture at the change to the higher mountain land.

Introduction.

The house history material contained below was researched around 2006 as part of a partial investigation into some farm holdings in Dyffryn Ardudwy, Merionethshire. Many references are noted which have not been looked up or copied. This document is a list of pieces of information (date; summary, full source) so far found about this house, and is not a prose history of the building & its owners or families. In early documents it is often not clear whether the area, farm holding or actual farmhouse is referred to; this can make it difficult to be sure when the farmhouse was first built. Building styles alter over time and buildings may be extended, modernised or totally replaced.

The notes do not always follow the format used in the house histories undertaken by the Discovering Old Welsh Houses heritage charity & its predecessors, and is not a complete house history. Nevertheless, it may be a useful starting point for house histories for any of the properties named. 1649-1660. The Commonwealth

William Phylip, (c1580-1670) born at Ty'n y Berth, near Tal y bont, and the poet farmer of Hendrefechan, just north of Egryn, was a staunch Royalist who suffered persecution during the Cromwellian period. "William Philip of Ardudwy, near Barmouth, for writing a pathetic elegy on the death of Charles I, fell under the violent resentment of the ruling power; his property was alienated – and himself, in his seventy-third year, was compelled to abscond and take refuge among the furze bushes and clefts of the rocks of the mountains of Ardudwy. ... William Philip, at length growing tired of his life as an outlaw, made his appearance, compromised matters with his persecutors, and returned to his house at Hendre. He was appointed tax-gatherer – high collector of Isartro in 1653".

His father was Phylip ap Sion ap Thomas ap Robert of Hendre Fechan, Llanddwywe, who died in 1625/6; his mother Catrin died in 1651 and both were buried at Llanddwywe. His wife Ann and daughter Elizabeth both died around 1653 and were buried at Llanaber. William wrote a series on *englynion* relating to the siege and fall of Harlech castle (1647). William died in 1669/70 and was buried at Llanddwywe. He left a son, Henry Williams, of Hendre Fechan who presented Mostyn Ms 144 to Griffith Vaughan of Corsygedol in 1678.

SUBJECT to a proviso in the said Indenture of Release that if the said John Williams, William Lewis & Catherine his wife and William Jones ... should pay unto the said William Griffith £1,000 with 5% interest on 12 May next, ... then William Griffith should convey the premises to them.

RECITING that the sum of £1,000 was not paid whereby the estate and interest of William Griffith in the mortgaged premises became absolute by law.

RECITING that by Indenture 12 November 1814 between

- 1. the said John Williams, William Lewis & Catherine his wife and William Jones;
- 2. the said William Griffith; 3. the said John Jones.

William Griffith agreed to lend a further £200 to 1.; security of the premises made to the said John Jones in TRUST for the said William Griffith ...;

RECITING that the sum of £1,200 remained owing to William Griffith;

RECITING that the said JOHN MAUGHAN agreed with the said John Williams, <u>William Lewis & Catherine his wife</u> and William Jones for the absolute purchase of the inheritance in fee simple ... at the price of £1,750 and that £1,200 be paid to William Griffith to discharge the mortgage.

WHEREAS (summary) The testator William Maughan died on 4 May 1887 his widow Elizabeth Maughan died 18 December 1888, & was buried in Ponteland co Northumberland.

WHEREAS (summary) the said John Maughan late of Corbridge, co Northumberland, retired master mariner, made his will dated 9 September 1891 and bequeathed all his estate to his brother the purchaser; and died 27 September 1891

WHEREAS Elizabeth Wilkins Smith died at Lenzic Glasgow N.B. on 9 December 1891 intestate leaving her husband William Henry Smith and the Vendor surviving her.

WHEREAS the vendor is the eldest son at law and heir ... & entitled to her third of the said ... lands

WHEREAS the vendor has agreed to sell to the purchaser his one third share ...

WHEREAS the Trustees have agreed to join the three shares and convey the whole to the purchaser
