### (Y) WERN: A History of the House & its Families

Llanfrothen, Gwynedd

update 27-3-2006

NGR 26200 34210 Grade II

From CADW Listing Schedule:

C16 gentry house, first mentioned in a rental book of Maurice Wynn of Gwydir, 1568-1574; in ownership of the Wynn family of Gwydir at least until the late Cl 7.

Sir John Wynn, son of the famous first baronet, lived here with his wife Dame Margaret from 1610 until his early death in Lucca Italy in 1614. A letter from Sir John (in Rome) to his steward in 1614, instructs him to keep the gardens at Wem in good order. The house was retained after Sir John's death as an occasional residence by the family. (Sir) Owen, his brother, had a bed and a large barrel of beer sent down during a lengthy visit he made in 1625 to escape the London plague.

The house was altered and raised in the early C19, perhaps for Richard Jones, the famous Calvinist Methodist minister and Writer, who lived here from 1819 until his death in 1833. Jones, bom in 1771/2, was a great believer in Sunday Schools and held one at Wem during his time there. He published several theological works and articles, some under the pseudonym "Cymro Gwyllt".

Exterior: 3-storeyed L-plan house of rubble construction on boulder and rock foundations; shallow-pitched hipped slate roofs. Central chimney at the intersection of the two arms, forming a lobby entry to the main (se-facing) front. The other wing has a gabled and projecting lateral chimney to the rear; both stacks have weather-coursing and simply-moulded capping, that to the latter much altered.

Interior: Lobby entry wing former hall to R of entrance. This has a primary late C16 fireplace with wide, stopped-chamfered bressummer; early C19 replacement beamed ceiling, Former parlour with fine primary beamed ceiling; wide stopped-chamfering to main beams and ogee stops to joists. Stopped-chamfered bressummer to lateral chimney. Plain, early C19 stick baluster stair with square newels. Pegged oak doorcases to most first and second-floor rooms, though mostly with modem boxingin; C19 king-post trusses to roof.

OWNERS: 2-12-05 update

Merioneth estates of Einion ab Ithel of Rhiwedog. (History of Gwydir Family, 1927, pp 1920; Ped-p 232, 234, 394)

cl460 death of Maredudd ab Ieuan of Ystumcegid, who had inherited the Rhiwedog estate in Merioneth through his wife. His son John ap Maredudd inherited a substantial estate in Penefed, Pennant, **Llanfrothen and Nanmor.** Ieuan ap Robert was John ap Mareduud's first cousin once removed. (JG Jones, The Wynn Family of Gwydir, p 13; C A Gresham, Eifionydd, 1973, pl9-20)

Maredudd ap Ieuan ap Robert obtained Y Gesailgyfarch & other lands in Penefed, Pennant & LLANFROTHEN. (J G Jones, 1995, Wynn Family of Gwydir, pl3-4) He

died in 1525, having fathered around 30 children.

Maredudd ap Ieuan's tenantry included Einion Gruffudd ab locows, a Ffestiniog & Llanfrothen freeholder, who was granted the Crown ffridd of Bryntyrch in Capel Curig, in the township of Trewydir. (JG Jones, WFG, p28)

1525-1559: son John Wyn ap Maredudd, died 1559.

1552- legal documents re his land holdings in Llanfrothen & other parishes (UWB Baron Hill ms 8, 9; Record of Caernarvon pp 281, 288-9; NEW Llanstephan ms 179B)

#### 1559-1580: His son Morus Wynn -1560-1580 rentals (CWP 94 pp 29-33)

inherited leases on the tenement of Elys Ifan in Llanfrothen. (JG Jones, HWG, p 46; Bye- gones 1888, 67)

1569 Llanfrothen freehold rent roll

1571: '¥ Wern demised for 4 years' (NLW Llanstephan msl79B, p 151). Tenant not named.

#### 1580-1627: His son, Sir John Wynn, inherited in 1580. He greatly enlarged Gwydir.

1583 John Wynn, his eldest son was bom.

1597: enters Bedford school; taught religion, Latin, Greek, Hebrew, instrumental & vocal music, French & Italian.

1601-1607: entered Lincoln's Inn - acquired qualities of diplomacy & leadership in preparation as heir to a sizeable estate.

1604 Began marriage negotiations. Marriage - cl605-6

1607 returned to Gwydir when he married Margaret, daughter of Sir Thomas Cave & his wife Eleanor of Northamptonshire. They lived at Gwydir for four years.

1607 Spring: a daughter, Eleanor, was bom. She died very young.

#### WERN, LLANFROTHEN:

It seems that there was a farmhouse called Y Wem by 1571.

John Wynn had spent several years in London in the early 1600s and would have been well aware of new trends in architecture.

Sir John Wynn would know well houses of men with court connections such as Sir Richard Clough's mansions of Plas Clough and Bachegraig built in 1567,

Plas Mawr, Conwy, Robert Wynn's grand town house, completed by 1595 and

Sir John Trevor's Renaissance house, Plas Teg built in 1610.

It is probable that Sir John Wynn would want to 'modernise' Y Wem before his heir moved there with his English wife, rather than let then live in an 'old fashioned' farmhouse which had not previously been a chief residence of the family.

Maybe this is why John Wynn lived at Gwydir alongside his father for some time. Wem would need to be appropriate for the entertaining necessary when, no doubt as Sir John Wynn had planned, his heir became sheriff of Merionethshire in 1611.

Whilst on his Grand Tour in 1614, Sir John Wynn junior is concerned about the maintenance of his garden at Llanfrothen. It is likely that this was a newly laid out garden, in keeping with the latest ideas.

#### By April 1610 John Wynn junior & his wife had settled at Y Wern, Llanfrothen.

(NLW ms 9054E, no 525, 534, 540) Sir John Wynn had stored his heir's demesne land at Llanfrothen with com & expected Lady Cave to provide household stuff to the

value of £100.

John Wynn & his wife had been well entertained on settling there, gifts being liberally given to them by tenants as tokens of affection. (NLW MS 9053E, no 448). He soon found defect in his wife, as did his father.

1610 John Wynn was appointed a justice of the peace and, in 1610-11 he became sheriff of Merionethshire.

1613 John Wynn, junior, was knighted.

1613 June: he departed from Gravesend for Calais. He visited France & Italy.

His Grand Tour of Europe was **financed principally by his own Llanfrothen rents** & his father's niggardly contribution. (JG Jones, HWF, p 61)

1614 May 3 lin a letter from Rome he urged his bailiff to send him the Llanfrothen rents, and in a postscript desired that Owen Jeffrey a servant, should care for **his garden at Llanfrothen**.

He died of the plague in Lucca, Italy, in August 1614, aged 31 years. In his will he bequeathed £5 to the poor of Llanfrothen.

What happened to the house & garden after the death of the eldest son?

1617 Rent Roll includes lands & rents in Llanfrothen: £269 14s Od. (NLW Ms 9056E.779)

1625 Owen Wynn to stay at Llanfrothen for six weeks. (CWP 1355)

1626-1649: **The 2<sup>nd</sup> son, Sir Richard Wynn,** inherited the Gwydir estate on the death of old Sir John Wynn.

1638 Aug 7: from Croysor, John ap Rudderch Owen writes to Maurice Wynn at Gwydir. Giving an account of various chief rents. Maurice Wynn's brother Sir John Wynn enclosed part of the commons of Llanvrothen. Does not know of any land in Maintoorocke save what was sold to Archdeacon Price. (NLW CWP 1803)

1649-1668: Sir Owen Wynn inherited as his brother Sir Richard Wynn died childless.

1653 Apr 5: from Llwyn, John Ellis wrote to Maurice Wynn of Gwydir, On behalf of a sister of the writer who has been a tenant of Wynn in Llanvrothen. Begs Wynn to reestablish her in the same tenement. (NLW CWP 2007; Add Ms 468E)

1654 Sir Owen's son Richard Wynn married Sarah Middleton. Sir Owen Wynn granted him properties in trust in Llanfrothen, Beddgelert... Valued at £600. (JG Jones, HWF p 105)

1655 Sir Owen Wynn obtained a license to search for and dig all leadmines within the wastes, commons and encroached lands in Bwlch y plwm (Ardudwy) ... for 7 years

? 1662 Hearth Tax for Llanfrothen.

#### 1668-1674: Owen's son, Sir Richard Wynn inherited.

On his death in 1674 the baronetcy passed to his cousin, Sir John Wynn of Watstay.

1674 On Sir Richard Wynn's death the vast Gwydir estate passed to his daughter, Lady Mary who, in 1678, married Robert Bertie, later first Duke of Ancaster. She died

in 1689. He died in 1723.

cl 717-1736 rent roll of Lord Willoughby de Ersby.

(UWB Mostyn Mss 5441, 5782, 5982, 5972; CWP2829, 2844-5, pp 424,426)

1674 - 1749 Part of Gwydir estates, apparently including those in Llanfrothen &

Beddgelert, were inherited by Sir Watkin Williams-Wynn I, 3<sup>rd</sup> Bart of Wynnstay. (NLW WynnstayL. 1301 includes Llanfrothen)

See several Rent rolls from 1683 - 1736 under tenants.

1749-1789 son, Sir Watkin Williams-Wynn II, 4th Bart of Wynnstay

1789-1840 son aged 17, Sir Watkin Williams-Wynn III, 5th Bart of Wynnstay
