#### HOUSE HISTORIES of FARMS once part of the EGRYN ESTATE

#### CAERAU, Llanaber parish, Merionethshire (at top of Cwm Sylfaen) NGR SH 638205

Partial House History by Margaret Dunn, revised 2020.

The house history material contained below was researched around 2006 as part of a detailed investigation into the farm holdings which had at some time been part of the EGRYN ESTATE, near Barmouth, Merionethshire. It does not always follow the format used in the house histories undertaken by the Discovering Old Welsh Houses heritage charity & its predecessors and in most cases is not a complete house history. Nevertheless, it may be a useful starting point for house histories for any of the properties named.

This document is a list of pieces of information (date; summary, full source) so far found about this house, and is not a prose history of the building & its families. It is hoped to include a detailed history of the Egryn & Caerberllan estates and their owners, families & tenants on the DOWH website as soon as possible.

It is not known when and how the ancestors of the Tyddur family of Egryn acquired these scattered holdings. They may be the remnants of a divided family estate shared by partible inheritance, or may include lands acquired by marriage.

1670s Jane Tudur, heiress of the Egryn estate, married Hugh Owen of Caerberllan, Llanfihangel y Pennant, Merionethshire, probably in the 1670s, being his second wife. After Hugh Owen's father's death, they moved to the larger & more modern mansion of Caerberllan, uniting the two estates.

1839 Llanaber is mynydd Tithe schedule (Dolgellau Record Office) Owner: Edward Pugh Owen

It is not known when the OWEN family sold this holding.

1911 Sale Catalogue of Lord Harlech's Land. Sylfaen & Golodd sold for £4,000 to Robert (Humphrey) John & Richard Williams, Llwynwcws. Sylfaen lands almost surrounded **Caerau** which was owned by E E Williams Esq. (Dolgellau Record Office, ZF/29 lot 276 & 277)

Probably too early for this to be Ellis Ewart Williams of Ystumgwern. (pers comm Gwyndaf Williams)

c1920 Caerau: A small mountain farm, 900 ft above sea level. There are no appearances of banks or ditches. Tithe schedule No 1,456. (Merionethshire Inventory of RCAHMW vi.50)

Glyn Edwards thought that the large barn was roofless in the early 1900s, pre 1920; the slates were removed for use elsewhere. (Pers Comm. Glyn Edwards Aug 2007)

1921 census not checked

Glyn Edwards' father rented Caerau for grazing sheep & cattle. In 1947, a very snowy winter, young Glyn had to carry a bag of hay on his back over Bwlch Rhiwgyr every day. The snows started on 29 January 1947. The Williams of Llwyn Cadwgan owned Caerau. (Pers Comm Glyn Edwards 2007)

Born c1930s at Goetre Uchaf, below Caerau in Cwm Sylfaen: Mr John Lloyd Williams, 25.....Clayton, Newcastle, Staffs. Might remember Caerau (pers comm Gwyndaf Williams)

After Hendre Eirian rented Caerau in the 1940s, it was bought by William Williams who then lived at Sylfaen, before he retired in the late 1940s-early 1950s and left Sylfaen. Chains for prisoners were still there some years ago but not now.

There was said to have been a tavern there on the old road

There was a well-built well, good for rheumatism, above Caerau, through a gate in the *ffridd* wall. (per comm Emlyn Williams, Bryn Derw. 2007)

It is now a ruin, part of the Sylfaen estate, belonging to the Evans family of Islaw'r ffordd (?Cae Daniel Caravan Park). The son lives at Sylfaen now (2007).
