#### House History Summary

Llawr-y-Dref is believed to be a 16<sup>th</sup> century gentry farmhouse with mural spiral stairs and ornate roof trusses, which according to Richard Suggett are one of the best examples of the Snowdonia style trusses.

It is possible Llawr-y-Dref as a tenanted farm came into the ownership of the Faenol estate (or Vaynol as referred to in some earlier documents) through the marriage of Margaret Jones of Castellmarch to Sir William Williams Bart in1640. It is not known who built Llawr-y-Dref as all Faenol records were destroyed by Arthur Owen in 1697. (Katie Lench, The Origins of the Faenol Estate 2010, p87) It has also been difficult to record the history of Llawr-y-Dref prior to 1777 as there are two farms of the same name in Llangian both having been part of the Faenol estate.

In 1907 the farm was purchased at auction, or privately at a later date by Evan Griffiths of Llanfihangelbachellaeth. Llawr-y-Dref was farmed by the Griffiths family until 1944 when it was tenanted out. The farm is now owned by Dr Griffith Tudor Owen, great nephew of Evan Griffiths.

#### RCAHM Vol.111 West Caerns. 1964, Llangian p 61, monument 1614.

A two-storeyed house probably of the 16<sup>th C</sup>. It is built of rubble and roofed with small slates; the S. gable and both chimneys have been rebuilt, but the roof and plain-chamfered eaves course appear to be original. Some of the internal arrangements have been altered and the original stone stair has been removed. Nothing is known of the early history of this house; the name has been transferred to a 19<sup>th</sup> C house nearby.

The present doorway, 3ft. 3ins. wide and set off-centre, has a depressed pointed arch. It is certainly an early opening, probably original, but the stones used are generally smaller than those in the blocked W. doorway. The windows on this E. front have all been altered, but that on the ground floor to N. of the door occupies an original opening. The two most southerly date from the rebuilding of the S. gable in the 19th C. During the course of this work much of the original fenestration in the W. wall was destroyed, but two small plain windows remain, only 1ft. 6ins. square The W. doorway 2ft. 7ins. wide, is opposite the present entrance; it has been blocked, leaving only a small window.

The lower part of the N. gable has been masked by the addition of a small 19<sup>th</sup> C. kitchen, but the upper part of the wall contains traces of a small window which once lit the stairs. The quoins are large and well built; the copings and the rough kneelers appear to be original.

The inner jambs of the E. doorway are widely splayed and retain one of the old door crooks in the S. jamb; the head is lintelled.

The interior has been altered, and all the present rooms are modern, but part of the original moulded post-and-panel screen remains in situ S. of the entrance passage. It contains two doorways with shaped heads, one to the W. and the other, blocked, near the centre. The principal room on the ground floor has its original ceiling-beams, with a well formed cavetto and double ovolo mould of Elizabethan type; the joists have a simplified version of the same mould. All lack stops. The fireplace-beam is similar, with plain stops. Traces remain W. of the fireplace of a stone stair, which was removed to give access to the added kitchen. The roof is ceiled and the woodwork could not be examined closely. The S. truss is modern, but the design of the other three suggests that they may be earlier than the building, perhaps from a medieval house on or near this site. All the roof woodwork is of excellent workmanship. The first or N. truss has only a plain cambered or even cranked collar. The second has a very slightly cambered collar with two cusped struts forming a central octofoil flanked by sexfoils. The third has the same arrangement of struts but has well-formed arched braces beneath the collar. It was impossible to reach the trusses to determine whether wind-braces had been used, but none now exist

Condition: fair.

House: probably late 16th century gentry's farmhouse, with mural spiral stair and ornate roof trusses...

The gentry family who built the house is as yet unknown. Its members may have married into the Castellmarch family, thus leaving Llawr-y-Dref as a tenanted farm adequately maintained but no longer subject to modernization or rebuilding as might be the case with a family home.

Llawr-y-Dref just may have been inherited by Faenol through other circumstances.

The roof trusses not suitable for dating by dendrochronology - too fast grown and no bark edges.

1640 Margaret Jones, co-heiress of Castellmarch married Sir William Williams, Bart. of Faenol, but she died in 1647 having borne Sir Griffith Williams, Bart. (JE Griffith, Pedigrees, p 190)

Their altar tomb can still be seen in the private (Faenol) chapel at Llanbeblig church, Caernarfon. (Katie Lench, The Origins of the Faenol Estate, 2010, p 60)

1645 Jane Jones, co-heiress of Castellmarch married (first husband) Thomas Williams, of Dinas, HSC 1646, brother of Sir Williams Williams of Faenol, but they were childless. (JE Griffith, Pedigrees, p 191)

Probable owners of Llawr-y-Dref as part of the Faenol estate:

- i) 1640s- 1658 Sir William Williams, Bart. of Faenol,
- ii) 1658-1669 Sir Griffith Williams Bart. of Faenol, .
- iii) 1669 -1696 Sir William Williams Bart. of Faenol,
- iv) Estate was left to Sir Bourchier Wrey, & then to his son, Sir Bourchier Wrey.
- v) But in 1698 the King granted the estate to John Gore.
- (Katie Lench, The Origins of the Faenol Estate, 2010, pages 60, 72, 78, 83.)
- vi) 1699 John Gore granted it to John Smith of Tedworth. John Smith devised the estate to his son vii)

Thomas Smith who died without heirs, leaving his brother

- viii) John Smith heir at law, and he left it to
- ix) His eldest son William Smith in 1720.
- x) 1764 William Smith died, having no children, left the estate to his nephew,
- xi) Thomas Assheton who took the name Assheton Smith, & was Lord Lieut Caernarfonshire & MPC in 1774. xii) His son Thomas Assheton Smith II died in 1828.
- xiii) 1776-1858: His son, Thomas Assheton Smith III, (owner 1828-1858).
- xiv) 1859 His widow devised the estate to her relative George William Duff (1848-1904) who assumed the name Assheton Smith in 1859, he was succeeded
- xv) in 1904 by his brother Charles Garden Duff who was created a Baronet in 1911. (JE Griffiths, Pedigrees, p187)

NOTE: The Llangian Church Records for Births, Deaths and Marriages (at GAS) from 1679 to 1767 have been checked, working backwards from 1767 to 1732, and they have references to Llawr-y-Dref, but as there are two farms of the same name there is no way of knowing to which farm they refer.

c1764 ñ 1770s: owner Thomas Assheton Smith I

c 1750 birth of John Griffiths, son of Mary Griffiths, later known tenant at Llawr-y-Dref.

c 1758 birth of Henry/Harri Griffiths, son of Mary Griffiths, later known tenant at Llawr-y-Dref.

(I have been unable to find any records of Mary Griffithis husband in the parish records)

First evidence that Llawr y Dref was part of the Vaenol estate.

Owner: Thomas Assheton Smith Esq of Faenol, Bangor

1777 Tenant: Mary Griffiths. The whole farm was 101 acres 3 roods, 36 perches.

(GAS, Faenol ms 4056, with map & field names)

1782 -1785 Tenant: Mary Griffiths. Land tax of 16s 0d.

1788-1789 Tenant: Mary Griffiths. Land tax of 10s 4d.

1793-1795 Tenant; Mary Griffiths. Land tax of 16s 0d.

1797-1818 Tenancy held jointly by John & Henry Griffiths for the rent of £33 per ½ year.

(GAS, Faynol ms 3751: 1799 rent book) Land tax for these years was 16s 0d.

(GAS. Land Tax Quarter Sessions XQA / L7)

Around 1800: Mary Griffiths was Lessee and occupier with her sons who managed for her jointly. The whole farm is now 103 acres, 3 roods & 36 perches. (a gain of 2 acres since 1777.) iThe buildings consist of a good dwelling house, barn, stable, and a range of houses, 2 cow houses, cart hovel, a cow house at a distance and a new house built by lessee for her son. Land not well managed, but capable of great improvementî. (R.O. Roberts, Farming in Caernarfonshire Around 1800. 1973, pp 37/38, 1973 Llangian Parish: Llawr-y-Dref)

Unknown: death of Mary Griffiths Llawr-y-Dref, 1795 onwards.

1826 August 27: death of John Griffiths of Llawr-y-Dref, aged 76 yrs. (Llangian Memorial Inscriptions GFHS, Aelwyd.) He was probably the elder son of Mary Griffiths, tenant in 1777 above)

1828: death of Thomas Assheton Smith II.

1841 Census Llawr-y-Dref: No record of Parish

Henry Griffiths aged 80, Tenant farmer All born in Caernarfonshire

John Griffiths 40 yrs. (son?),

Elizabeth Griffiths 39 yrs. (daughter?) Ann Griffiths 35 yrs. (daughter?) Judith Jones 12yrs (servant?)

1834. In Memory of Ellin Jones Wife of John Jones, Joiner and daughter of Henry and Elizabeth Griffiths Llawr-y-Dref who died September 1834 Aged 40 years. Also Elizabeth Wife of John Thomas, and sister to the above Ellin who died November 22<sup>nd</sup> 1876 aged 79 years old. (Llangian Memorial Inscriptions GFHS Aelwyd) There appears to be no record of Elizabeth Griffiths wife of Henry Griffiths in the Llangian Parish Records.

1844 December 12: death of Harri Griffiths, Llawr-y-Dref aged 86 yrs. (Llangian Memorial Inscriptions GFHS Aelwyd)

1881 Census Llawr-y-Dref

November 1882, May 1883, John and his sister Ann Parry farmed Llawr-y-Dref jointly. (GAS.Faenol Rental Records 3918 p64, Rent paid £49.)

November 1884, John Parry was represented by his sister Ann. Rent paid £6, in arrears of £11. May1885 rent was £20, rent paid £31 paid in full plus £11 arrears. (GAS Faenol Rental Records 3920 p67). Possible death of John Parry May 1885-November1885.

No record in the 1881 Census of where born or Parish

November 1885 and May 1886 the tenant is Henry Griffiths. The November rent owed and received was £49. May 1886, rent was £46 15s. rent received £42 1s 6p. Henry was given 10% allowance. (GAS. Faenol Rental Records 3921 p67.)

November 1886 and May 1887, Henry Griffiths was again given an allowance of 10%. (GAS. Faenol Rental Records 3922 p67)

Was the 10% allowance given because the farm was run down and neglected by old John Parry prior to Henry Griffiths becoming the tenant?

By age, name and 30 years time span since the 1861 census it seems very likely that they are the Griffiths mentioned as nephew, wife and son in that census.

1901 Census No entry for Llawr-y-Dref for this year.

1907 Pwllheli Town Hall Faenol Estate Auction

Lot 80 -108 acres farm Llawr-y-Dref Llangian, part of the Faenol Estate.

Occupied by Henry Griffiths and J.P. Griffiths as yearly tenants.

Probably the same Henry and J.P. Griffiths of the 1891 census.

The farm was purchased at auction (or privately later) from the Faenol Estate by Evan Griffith (1870-1910). Born at Beudy Mawr, Llanfihangelbachellaeth he farmed with his mother Margaret and and sisters Elizabeth (1867-1950) and Cathrine (1878-1916). Evan Griffith died in 1910.

Being a close family, the farm was inherited by Evan's siblings.

1910? Owen (1864-1948) and Jane Griffith (1873-1944), Evans brother and sister, who at the time farmed Bodsela Llanfihangelbachellaeth which was then let to a tenant, took over the farming of Llawr-y-Dref. Exactly when this occurred is not known as Owen Griffith owned and farmed a number of farms.

#### 1911 No Census available.

1916 on the death of Cathrine Griffith her inheritance went to her daughter Margaret Griffith (later Owen on her marriage to Griffith Gwilym Owen LDS 1906-2005)

1944 Death of Jane Griffith. Owen went to live with his surviving sister Elizabeth Griffith and his niece Margaret Griffith Owen (1914-2002),

1944 Llawr-y-Dref let to a tenant William Owen (no relation to Margaret Owen).

1948 Death of Owen Griffith.

1948 Ownership of Llawr-y-Dref passed to surviving sister Margaret Griffith and his niece Margaret Griffith Owen.

1950 Death of Elizabeth Griffith.

1950 Margaret Griffith Owen became sole owner of Llawr-y-Dref.

1963 William Owen gave up the tenancy because of ill health.

1963 Llawr-y-Dref was partly held for 1 year.

1964 Llawr-y-Dref held entirely by John Jones until he died in the late 1990s. His family did not want to carry on with the farm because of pressure of work elsewhere.

Since then various farmers have held Llawr-y-Dref on summer grazing and sheep wintering lets.

2002 Death of Margaret Griffith Owens.

2002 Sons Dr Griffith Tudor Owen and William Jones Owen, MS. FRCS Consultant and Clinical Director of surgery, Guy's and St Thoma's Hospitals London (1945-2003) became owners of Llawr-y-Dref 2003 Death of William Jones Owen

2003Dr Griffith Tudor Owen, great nephew of Owen Griffith, became the present and sole owner of Llawr-y-Dref. All the deceased family members are interred at Llanengan Church.
