

## DISCOVERING OLD WELSH HOUSES

### HOUSE HISTORIES of FARMS once part of the EGRYN ESTATE

#### RHYD YR EIRIN, Llanfair parish, Merionethshire. NGR SH 615313

The house history material contained below was researched around 2006 as part of a detailed investigation into the farm holdings which had at some time been part of the EGRYN ESTATE, near Barmouth, Merionethshire. It does not always follow the format used in the house histories undertaken by the Discovering Old Welsh Houses heritage charity & its predecessors and in most cases is not a complete house history. Nevertheless, it may be a useful starting point for house histories for any of the properties named.

Only a limited number of the fifteenth century holdings bear topographical names. ... These holdings appear to represent the partitioning of the old tribal lands following the Conquest. .... Bennar, Taltreuddyn, Ystumgwerth. ... Bron y foel occupies the highest position (*along the coastal strip*) today represented by a farm lying at just above 650 ft. This high position, on the edge of the moorland, is paralleled by that of **Rhyd yr Eirin in Llanfair**, today a former farmhouse located at 900 ft on the rocky slopes of Moel Gerddi, and by Golodd, lying on the lower slopes of the Llawlech ridge in the valley of the Afon Dwynant at 750 ft. (Della Hooke, *The Arduwy Survey*, JMHS, 1983, p 248)

*It is probable that the Rhyd yr Yryn land was acquired by the ancestors of William Tydur of Egryn between 1580 and 1623 by purchase from the crown or other owners. It is not clear when a house was built of the land.*

Mid 1600s: Dendrochronology sampling was undertaken by the Oxford Dendrochronology Laboratories in January 2016 & the March 2016 report states that although it was not possible to obtain felling dates from any of the timbers, it is likely that the building was erected in the mid 1600s.

*1706 William David (Llanfair Church-wardens' accounts); (wife Gwen), tenant of Rhyd yr Eirin (born c1680?) Perhaps he was William David (pauper) and husband of Gainor. Daughter Ellen baptised 20 March 1702; Daughter Lowry baptised 14 Nov 1708; son David baptised 14 Oct 1710. ... As tenants of Rhyd yr Eirin they were still represented by Anne (David) (1805-1856) in the 1850s. She married Robert Lloyd (1790-1869) of Llechwedd-du-mawr, a younger brother of Evan Lloyd of Cilcychwyn.*

Robert Lloyd (1743-1805) son of Evan Lloyd (d 1785) of Cwm Bychan, in 1775 married Elen/Ellinor Jones (1757-1839) at Trawsfynydd. By the birth of their third child Jane (1787-1849) they were living in Llandanwg parish, probably at Llechwedd-du, which became the family home. ... Their youngest son Robert Lloyd (1790-1869) also farmed at Llechwedd-du and later moved to **Rhyd yr eirin**. He married Ann Dafydd (1805-1856) of Rhydyreirin, Llanfair parish. He became tenant of **Rhydyreirin** in succession to his father in law Dafydd William (bapt 1759) who was, in turn, a son of William Dafydd (died 1801) of **Rhydyreirin**. Robert and Ann had at least three children: Ann (born 1836); Eleanor or Ellen (born 1841); and Robert Lloyd (born 1844). The tenancy remained in the family as it was later held by Eleanor's husband, Joseph Owen. (Lewis W Lloyd, *The Last Lloyd of Cwm Bychan*, JMHRs, 1975, vol VII, p 260, 281 n 49)

*His (William David's) descendants from c1754 (Davids, Williams, Lloyds & Owens) were apparently still at **Rhyd yr Eirin** to around 1920. See Lewis Lloyd and "Recollections from the Manweb man" etc etc. (Ledger Pers Comm., family book – see Llanfair churchwardens accounts)*

1801: Parish of Llanfair juxta Harlech had a population of 369, rising to 419 in 1821. **Rhyd yr Eirin** was at this time part of the Corsygedol Estate. (Ledger Pers Comm-family book)

The grand UPLAND FARM is considered one of the best in the County, noted for its butter producing properties, and for sheep and cattle grazing it cannot be surpassed. Distant 2 miles from the well-known sea-bathing and ancient town of Harlech; commanding a grand panoramic view of the promontory of Llyn, Criccieth Castle to Portmadoc and the entire expanse of Cardigan Bay.

The walls are in excellent condition, with good dwelling-house, and several buildings scattered over the whole farm, and it has a plentiful supply of water, and peat for fuel. NB This fine estate as a whole would make a fine sporting property for both the gun and rod. There are 30 good trout lakes within easy reach.

Joseph Owen kept 60 sheep over winter, 5 cows and 3 bullocks were fattened each year. His daughter made butter which she sold in Barmouth. There were sloe trees by the ford.

Joseph Owen's wife died; he and his daughter lived there in squalor; the daughter Anne Owen died; Joseph Owen went to live elsewhere. (Mr Ledger, pers comm.. 2007)

From 1879: The Richards family of Pensarn owned Rhyd yr Eirin and Ffridd, Llanfair

1921 March 4: conveyance for £500 1. Robert Richards (vendedor); 2. Evan and Janett Parry (purchasers) (she died 5-5-1921) Rhyd yr Eirin occupied by Joseph Owen. 32 acres 3r 6p. (Mr Ledger pers. comm.)

Evan Parry lived there in the 1900s; he kept a pig in the living room. The Council declared the house unfit for habitation.

Mr Parry took over; he was some 80 years old when he sold the farm to Mr Pugh of Ffridd Llwyn Gwrfal.

After Mr Evan Parry and his daughter Margaret left, Rhyd yr Eirin became a barn.

1953 Mr Pugh died; Rhyd yr Eirin was left derelict. (Ledger pers comm.)

1954 Conveyance David LL Richards to David LL Richard & his wife Jane Richards both of Awelfryn, Llanbedr. (Ledger pers comm. Abstract of Title)



1955 July 16: Death of D LL Richards. (Ledger pers, comm. Abstract of Title)

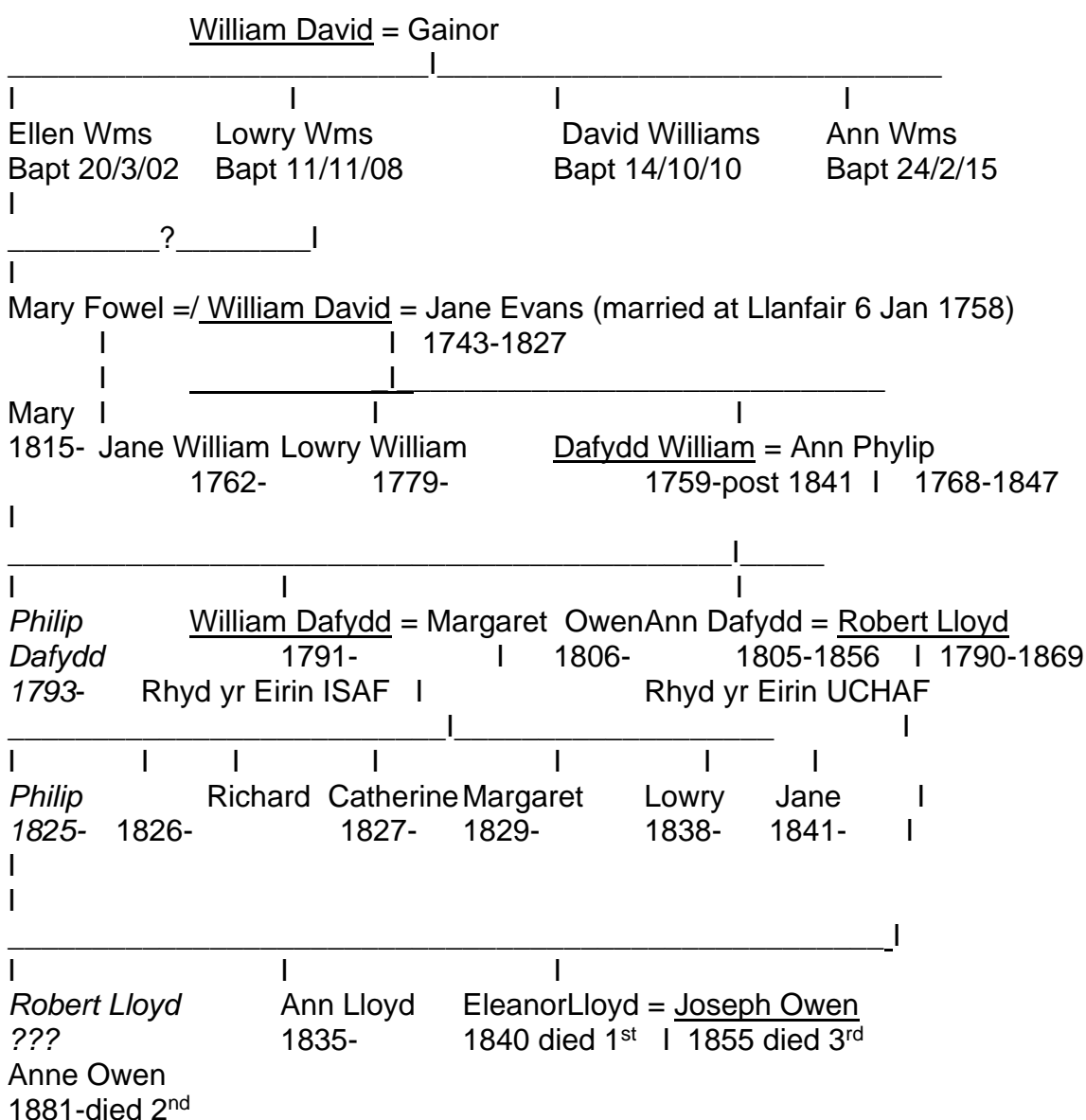

1959 Rhyd yr Eirin house was sold for £100 to Mr Ledger, London, who restored it. Holiday cottage. Later joint owners with husband Paul; still owners in 2007.

c1966 Rhyd yr Eirin land was sold to John Pugh of Ffridd, whose son Hywel Pugh, Tyddyn Sionwyn owned it in 2007.

Fridd farmhouse was soon sold on to Chris King who lived there in 2007. (pers comm Elwyn Evans, Gerddi Bluog)

ANOTHER TREE prepared by the Ledger family (Pers Comm.):

**William David**, in 1758 married Jane Evans, at Llanfair; witnesses: Ellin Wynne & Harry Robert.

William & Jane had Jane Williams, baptised Llandanwg 12 Dec 1762; Lowry Williams, 1779 and Dafydd Williams baptised 28 March 1759 at Llanfair.

William David of Rhyd yr Eirin, was buried 10 Sept 1801 at Llanfair.

**Dafydd William** (1759-1851) in 1791 by licence at Llandanwg married Ann(e) Phylip (1768 baptised 1 April, Llandanwg -1847). Witness: David Griffiths & John Jones. She was a daughter of Philip Humprey buried Llandanwg 12 Aug 1800, and Margaret.

Dafydd and Ann had Philip Dafydd, baptised Llanfair 20 Feb 1793; Philip married Margaret and had Philip 20 Oct 1825;

William Dafydd baptised 10 July 1791, lived at Rhyd yr Eirin; and

**Anne Dafydd** (1805-1856 buried Capel Rehobeth) married Robert Lloyd (1790-1869). They had Robert Lloyd, born Llanfair parish & aged 7 in 1851 census; Ann Lloyd, born Llanfair & aged 15 in 1851 census; Ellen / Eleanor Lloyd born in Llanfair parish & aged 10 in 1851 census.

**Ellen / Eleanor Lloyd** married Joseph Owen and they had Elizabeth H Owen ( 1878-1892 March 12, buried Capel Rehobeth).
