HOUSE HISTORY

RCAHMW, Caernarvonshire, Vol II, 1960, p22 (709). Visited Oct 1953.

A rubble-built single-storey cottage, originally of one room 22ft by 17ft, with walls 3-4ft thick, probably of the 17th century, but standing on a platform projecting to the S which may be the remains of an earlier house. There is a small square window on each side of the front door. At the N is a squat chimney. Inside there is a wide fireplace with a recess. All partitions are modern. There are two semi-crucks; that at the N is complete, but not the other. The present collar appears to have been the base of a cruck re-used. It is possible that the crucks are part of the structure of an earlier house incorporated in the present building. Condition: good.

RCAHMW files: Notes by PS, CHH; Oct 1953. Condition good.

The present building is probably 17th C standing on a platform which extends beyond the house to the S and probably carried an earlier building. The roof trusses differ in type and suggest the hypothesis that they were used in the previous building as the crucks. The N cruck was re-used in its entirety for the 17th C building. The S cruck had become so rotten that it had to be broken up and only part used. The collar of this truss is clearly the base of a cruck and the east principal has a slot for a collar which is not used, the collar being pegged.

Treatment? Sketch plan? But interesting site and impossible to get all the above information on such a plan.

Notes on plan:

Square chimney; rough copings at gables; originally no loft.

N upper cruck with let in collar. S tusses of re-used material including part of upper cruck.

E (back wall) window converted into door to later building. Modern partitions not shown.

To S break. Foundations of earlier ?platform house.

From CADW Listing schedule:

Small vernacular cottage, probably of the early C17, but **incorporating cruck trusses (one as a collar) probably reused from an earlier, timber-framed house on the site**; the elevated location is suggestive of the site's early origins and the presence of a platform projection to the S would appear to support this.

Two-bay interior probably originally incorporating a crogloft. **Central collar truss of which one principal is a (probably re-used) cruck blade, as is the collar.** Wide fireplace to chimney end (L) with flat oak bressummer; C20 partitioning.

OWNERS the Wynn of Gwydir family

c1460 death of Maredudd ab Ieuan of Ystumcegid, who had inherited the Rhiwedog estate in Merioneth through his wife. His son John ap Maredudd inherited a substantial estate in Penefed,

Pennant, Llanfrothen and Nanmor. Ieuan ap Robert was John ap Maredudd's first cousin once

removed. (J G Jones, The Wynn Family of Gwydir, p 13; C A Gresham, Eifionydd, 19-20)

Maredudd ap Hywel dwelt at both Cefii y fan and Gesail Gyfarch. His sons were

1) **Ieuan ap Maredudd** who died in 1403 in the Glyndwr uprising. Ieuan supported the King and Glyndwr's men burnt down both Cefii y fan and Gesail Gyfarch 1 in 1403. Ieuan ap Maredudd's grandson was the founder of the Clennau estate.

2) **Robert ap Maredudd** from whom the Wynn family of Gwydir were descended. Robert ap Maredudd supported Owain Glyndwr, was pardoned by the Henry V in 1422 and married when he was about 80.

Robert ap Maredudd's son, was **Ieuan ap Robert (c1437-1469)**. In 1462 he received y Gesail Gyfarch as his inheritance. This was probably the repaired house on site 2. Between 1462-68 the hall of Ieuan ap Robert's house was attacked. He was active in the Wars of the Roses until his death of the plague, aged 31 in 1469.

His eldest son, **Maredudd ap Ieuan ap Robert (1460-1525)** was of Crug, Dolwyddelan castle, Penamnen and then Gwydir. He was the founder of the Wynne family of Gwydir.

DENDROCHRONOLOGY results as follows:

Front (W) cruck

Felling date Winter 1494/5

Front (W) principal rafter

Felling date Winter 1494/5

Front (W) upper purlin

Felling date Winter 1494/5

Rear (E) upper purlin

Felling date range 1493-8

The front (W) cruck, principal rafter and upper purlin were all felled in the winter of 1494/5. If reused from an earlier building on the site, would these timbers have been re-assembled without visible modifications? Might they be in their original positions and the building modified around them with the addition of the N gable chimney and the removal of a S bay?

The Dendrochronology results for Gwastadannas give a felling date of 1508 for one pair of cruck blades. Are there similarities in style or dimensions between Oerddwr Issa (1495) and Gwastadannas (1508) which might suggest the use of the same carpenters by the same owner?

Situated in a sheltered hollow on a steep south-facing hillside about 120m above O.D.

Chimney-gable end into the hillside. Front of house facing ?WEST. Nearby stream. Old thick slate roof lost in earthquake c1984; re-covered with corrugated iron sheets. Timbers all painted black.

The lost lower end appears to be on made land, so may have been lost due to unstable foundations.

Oerddwr-isaf Beddgelert, Gwynedd (NPRN16620)

An upland farmhouse of medieval origin sited about 120m above O.D. The present house appears to incorporate part of the fabric of a hall-house whose platform extends beyond the present three-bay house. A felling date of winter 1494/5 was obtained from the surviving cruck truss. For description, see RCAHMW, Caernarvonshire Inventory II (1960), 22, no 709. (R Suggett, RCAHMW, Annual Review, 2006-07, p55)

Beddgelert, Oerddwr-isaf (SH 5907 4543)

Felling date: Winter 1494/5

An upland farmhouse of medieval origin incorporates part of the fabric of a hall-house whose platform extends beyond the present three-bay house. The truncated house was of crogloffft type with an upper-end chimney, cruck-truss central to an open hall and passage, and a rest partition truss with a lapped collar (probably a reused section of cruck blade) replacing a morticed collar. The fireplace beam was unsuitable for sampling. Description in RCAHMW, Caernarvonshire

Inventory II (1960), 22, no 709. (Vernacular Architecture, vol 38, 2007, List 193, Welsh

Dendrochronology Project phase 11, p 134)

In 1506 Maredudd ab Ieuan ap Robert (c1470-1525) and his oldest son John Wynn ap Maredudd (c1492-1559) were appointed, by Abbot Dafydd ap Owain, stewards for life of the Nanhwynan lands and the other Caernarfonshire lands of the Aberconwy monastery, joining Maurice ap Rhys (Morris Gethin) of Plas Iolyn who had been appointed steward in Hiraethog in 1501.

(R W Hays, *The History of the Abbey of Aberconway*, 1963, ppl74-75; C A Gresham, 1983, *The Aberconwy Charter*; further consideration, BBCS XXV, p 337).

In 1508 Maredudd ab Ieuan ap Robert obtained from Dafydd, the abbot of Aberconwy the leases, of the holdings in Nanhwynan of Bwlch Murchan, Gwastadannas, Hafod Tandreg, Llyndy, Hafod-y-porth, Cwmdyli, Wemlasdeg and Glasdraian. (UWB, Baron Hill Ms 3206; C A Gresham, 1983, *The Aberconwy Charter*; further consideration, BBCS XXV, p 337).

c1500-1525: **Maredudd ap Ieuan ap Robert** obtained Y Gesailgyfarch & other lands in Penefed, Pennant & Llanfrothen. (J G Jones, 1995, *The Wynn Family of Gwydir*, p13-4) He died in 1525, having fathered around 30 children.

His 1528 Eifionydd rental includes Gesail Gyfarch, where he had probably never actually lived.

1525 **John Wynn ap Maredudd**, (c1492-1559) the eldest son from his first wife, inherited from his father. (C A Gresham, 1973, *Eifionydd* p 89)

Oerddwr Issa is NOT identifiable in 1528 Rental of lands of Maredudd ap Ifan ap Robert (C A Gresham, 1973, *Eifionydd* p 391)

1552- legal documents re his land holdings in Llanfrothen & other parishes (UWB Baron Hill ms 8, 9; Record of Caernarvon pp 281,288-9; NEW Llanstephan ms 179B)

Oerddwr Isaf and Aberglaslyn in Pennant are named by Gresham as part of John Wynn ap Maredudd s share of Maredudd s possessions. (C A Gresham, 1973, *Eifionydd*, p89)

1559-1580: **Maurice Wynn of Gwydir** inherited from his father.

1560-80 Rental of lands in Eifionydd from CWP No 94, Memorandum book of Maurice Wynn of Gwydir p32; **Oyr ddwr 5 shillings**. (C A Gresham, 1973, *Eifionydd* p 393)

1572 Orwrdwr bach: tenant Thomas ap William (NLW, Llanstephan ms 179b, p 167)

1580-1627: His son, Sir John Wynn, inherited in 1580. He greatly enlarged Gwydir.

1626-1649: **The 2nd son, Sir Richard Wynn**, inherited the Gwydir estate on the death of old Sir John Wynn.

1631 Sir Richard Wynn of Gwydir owned **Oerddwr & Aberglaslyn**, inherited from Maredudd ap Ifan of Gesail Gyfarch. Freehold 5 shillings together. (C A Gresham, 1973, *Eifionydd* p 44, 50)

1649-1668: Sir Owen Wynn inherited as his brother Sir Richard Wynn died childless.

1654 Sir Owen s son Richard Wynn married Sarah Middleton. Sir Owen Wynn granted him properties in trust in Llanfrothen, Beddgelert Valued at £600. (J G Jones, *The Wynn Family of Gwydir* p 105)

? 1662 Hearth Tax

1668-1674: Owen s son, Sir Richard Wynn inherited.

On his death in 1674 the baronetcy passed to his cousin, Sir John Wynn of Watstay.

1740 Sir Watkin Williams Wynn I inherited Wynnstay through his mother, including these estate lands.

1740-1749 Part of Gwydir estates, apparently including those in Llanfrothen & Beddgelert, were inherited by Sir Watkin Williams-Wynn I, 3rd Bart of Wynnstay. (NEW Wynnstay L. 1301 includes Llanfrothen, Diet Welsh Biography, pl 100; C A Gresham, 1973, Eifionydd p 101)

1749-1789 his son, Sir Watkin Williams-Wynn II, 4th Bart of Wynnstay

1756 Oct 12: Deposition including reference to right of the tenants of Havod y Llyn to graze cattle and horses on Morfa Havod y Llyn otherwise Morva Maen Rhiw on both sides of the river quite to **Hendre Oer Ddwr** and Dinas Du meadow. [References to the river running into two branches, and the greatest current running close or adjoining to the wall and fence of Hendre Oer Ddwr and Dinas Ddu]. (NLW Dolfriog 249)

1785 Rental Land Tax Assessment Owned by Sir Watkin Williams Wynn II of Wynnstay. He had inherited in 1740, through the mother of Sir Watkin I, it having been the property of Sir John Wynn, the last baronet of the direct Gwydir line, who died 1718/19.

In 1801-3 young Sir Watkin Williams Wynn III decided to sell outlying portions of the old Gwydir estate. Oerddwr NOT mentioned by name. (1801 Sale Particulars for detached estate by Sir Watkin Williams-Wynn in co C; C A Gresham, 1973, Eifionydd p 102; UWB, Forth yr aur 19,710; Bye-Gones 1887, p 343)

1803 April 1, 2: Oirdwr Issa, parish Bedcelert, occupier William Griffith, (also names estate s farms & tenants in Nantgwynant) (GAS XM/1041/33, Papers of Sprott, Stokes & Turnbull, Solicitors, Shrewsbury)

David (bom 1937) abroad & Gay (bom 1947) grew up at Plas Oerddwr. Gay has photos of the old house c 1959.
Mrs Parry (?housekeeper) and her daughter Carol lived in the old cottage. Carol s father was a GI & she now lives in Canada.

Then another couple lived there; they painted the fireplace green, much to Col Goodchild s disgust,
c1980 Col Goodchild died at Cwm Caeth, Nantmor, his daughter s home.
His son David Goodchild inherited
2008 He owned Plas Oerddwr and the old cottage when the dendro sampling took place.

2011 David Goodchild sold to Mr & Mrs Banks from Menai Bridge.
