Tŷ Cerrig was formerly known as Plas Newydd which suggests a previous dwelling although there is no documentary evidence of this.

The first documentary evidence we have of habitation at Plas Newydd is in the 1662 Hearth Tax when one Edward Wynne lived there. *CCHM : 2:1(1953) page 22*

Edward was used alternately as a Christian name for the Wynnes of Ty Cerrig as this was common practice in Wales. The first son would be named after the grandfather on the father's side and the first daughter would be named after the grandmother on the mother's side.

1681 Edward Wynne, There were 12 people living at Plas Newydd, 7 under 18 years aged :- 15, 13, 9, 5, 4, 6, 1.

1686 Margaret Wynne, 5 people living with 4 under 18:- aged 13, 14, 12, 7

1686 Edward Wynne 6 people living 1 under 18 ; - age 5 this was his son Robert Wynn

June 1779. Due to the many debts he had incurred, the will of Edward Wynne brought about a Bill of Revival and Supplemental. Richard Jones being the plaintiff and Rev Howell Wynne Jones clerk, brother and heir of Edward Wynne Esq. deceased, was the defendant.

Richard Jones appointed John Jones of Black Hall County Montgomery as his bailiff to receive the debts and profits of the estate at a salary of £20 per annum for 4 years between Ladyday 1775 and Ladyday 1779. Richard Jones found by experience that it was greatly beneficial to give the tenants a dinner on the day the rents were due as it would ‘encourage them to punctuality’. Forty two shillings was to be expended by his Bailiff for that purpose.

Several tenants were in arrears but Edward Wynne, deceased, had greatly neglected the necessary repairs to the farmhouses and outhouses. The outbuildings were in such a state of decay that they were in danger of collapsing and the farmhouses in becoming inhabitable.

The tenants threatened to quit the farms as they feared being buried in the ruins.

The farms had been mortgaged and there were several bonds and debts. By September 1773 the Bond and debts due had risen to £ 3,719. 10.

It was during this time, 1774, that Ellis Cadwaladr (born 1748) became the tenant of Plas Newydd and from that time the house was referred to as Tŷ Cerrig. *Adgofion Andronicus*¹ page117ⁱ (There are photographs that show the sorry state of the buildings)

Andronicus writes that there used to be a cellar full of water under Ty Cerrig and ducks and geese could be found swimming in there.

Following him, his son Edward Ellis, farmed Tŷ Cerrig. He died in 1834 at the age of 74 and is buried at the Church in Llangower also both his wives and a 25 year old daughter. When he was courting his first wife Jane, Bala lake was frozen over, so Edward Ellis managed to walk across the lake to save on the journey round through Llanuwchllyn to Parc, Bala. It was years later that he realised what his impetuosity and daring could have resulted in.

Thomas Ellis, his son, then farmed Tŷ Cerrig but in 1855 moved to farm Cynlas, Llangywer, that is where his famous son T I Ellisⁱⁱ was born.

The Ellis family were Nonconformist and totally different to the previous occupants, the Wynnes, who squandered their inheritance through excessive drinking and gambling. One of the Wynnes drowned on his way home from a dance. *Andronicus*

In 1774 Ty Cerrig came into the possession of Rev. Howell Wynne, Llangwm, heir and brother in law of Edward Wynne deceased. *C106/197 Pam ButtreyNotes*ⁱⁱⁱ

1798 Will of Cadwaladr Ellis

He gives £8 to each of his three daughters and the rest of his goods to be shared equally between his son Edward Ellis and his wife Gwen but only £2 should his wife remarry.

ⁱ Andronicus- (John William Jones 1842-93) He worked as a commercial traveller in Manchester then suffered from rheumatism and became an invalid. He wrote articles for newspapers and then wrote a book about his reminiscences of living in Llangywer.

^{iv} Isaac Gilbertson. He was a recorder appointed by the lord of the Manor of Mawddwy and was generally an attorney – a paid post *Cymdeithas Hanes Merionnydd* 1:1 (1949 page 51)
